We are an Australian non-profit organisation (COVERSE, <a href="https://coverse.org.au/">https://coverse.org.au/</a>) that is 100% in the hands of individuals who have been injured by a Covid-19 vaccine. We work closely with counterparts around the world, including React19 in the USA (<a href="https://react19.org/">https://react19.org/</a>).

In light of your current review into the adverse events associated with vaccines, we present several important documents from Australia and hope that you include these in your review.

## Western Australia adverse event surveillance

The state government of Western Australia recently released its adverse event surveillance report for 2021. This is a globally important report as 2021 was the year that the majority (close to 100%) of adults in that state were vaccinated with a Covid-19 vaccine, and during this time there was zero Covid circulating in the community.

## **Long Covid inquiry**

Our federal parliament has been holding an <u>inquiry into Long Covid</u>, and as part of this process there have been a number of submissions related to the Covid-19 vaccines, including a detailed submission from ourselves. Our submission focussed on the lack of medical, regulatory, research, or financial support to people who have been negatively impacted by these vaccine products, however we also detail some of the known science and included references to numerous important studies.

Of most note is a condition we call "Long Vaccine Syndrome" (known as Post Vac Syndrom in Germany), which appears to mirror Long Covid in very many respects (which itself appears to mirror ME/CFS). This condition is not currently recognised as being caused by vaccines, despite enormous numbers of people being impacted in this way. It is recognised that pharmacovigilance systems are generally poor at detecting such complex multi-symptom conditions. Coupled with a general lack of understanding about identifying and treating these diseases amongst medical professionals, it appears as though a major safety signal has gone undetected (or dismissed) by virtually every responsible drug safety agency in the world.
